

## Mewburn sources

*This is a collection of secondary source citations that encompasses pretty much all that has been written about the Mewburns, including material that exists in archives but has not been published. Of these sources there are a few written by Mewburns, some that relate to Mewburn family history, some that summarise the lives of individual Mewburns, others where Mewburns or a family are mentioned in passing. There is little that deals with Meaburns, though the Pontop Meaburns are mentioned in Burke's Commoners and a Tasmanian website has written about those who settled there.*
